- i) The need-based scholarship award is initially valid for a period of 01(One) year and would be extendable periodically, subject to the satisfactory performance of his/her studies.
- ii) The payment admissible under the scholarship program shall be made subject to the complete adherence to all rules and regulations governing the *concerned university/Institute as well as satisfactory performance in the authorized studies.
- iii) The awardee/scholar shall not change the specified course of studies of scholarship program at any stage nor register himself/herself for any other course or program/University/Institute at any stage, without prior approval of the both *concerned university/Institute and NTS.
- iv) The awardee/scholar shall not extend the specified period of studies without prior approval of the both *concerned university/Institute and NTS.
- v) In case the awardee/scholar fails to maintain the required standard or qualify the course/degree for which he/she was awarded scholarship, the *concerned university/Institution reserves the right to cancel his/her scholarship.
- vi) The awardee will be liable to disciplinary action as follows:
 - a) If he/she fails to obey or act in accordance with *concerned university / Institution's orders, procedures, policies, rules regulations, directions, he/she may be liable for disciplinary action under the acts/rules of the *concerned university / Institution.
 - b) If he/she violates any condition laid down in the Deed of Agreement / scholarship rules for studies under the NTS Need-based Scholarship Program, he/she may be liable to pay the penalty (if any) as prescribed by the *concerned university / Institution.
- vii) The awardee is liable to disqualification from NTS Need-based scholarship or such other disciplinary action as *concerned university / Institution may consider appropriate, if:
 - i) He/she violates any of the foregoing conditions, or
 - ii) He/she is found to have made any misstatement therein before.
